# Your rights

- 19. You have the following rights in relation to your Data:

- c. Right to erase- the right to request that I delete or remove your Data from my systems.
- d. Right to restrict my use of your Data the right to "block" me from using your Data or limit the way in which I can use it.
- e. Right to data portability the right to request that I move, copy or transfer your Data.
- f. Right to object- the right to object to my use of your Data including where I use it for my legitimate interests.

- 28. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.
- 29. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
